All of the contracts went well and members voted overwhelming to ratify their contracts with the exception of one. The FOX TV contract was ratified by a vote of 18-17 even though the Union office along with the committee recommended that the members reject it. FOX management entered negotiations with a mission to break down the group. After 10 months of negotiations, the members felt too much pressure and accepted the Companies last, best and final offer. I would like to thank our committee for their hard work and dedication to their fellow workers.

**SOLAR.** As of this writing, there are approximately 350 IBEW members working on large solar projects in 110, 292 and 343. 2017 looks be as strong as 2016. We need to continue to fill the calls. The competition is fierce. If we want this work to be done by the IBEW, we need to protect it. There are many that would like to do it.

**VOTE ON NOVEMBER 8TH.** Please get out and vote. This election is extremely important. The best way to prevent Right to Work is to elect candidates that oppose it. Minnesota has one of the highest standards of living in the country, let's keep it that way.

Business Representative Steve Ludwig



In our continuing efforts to upgrade the learning experience, we created new fire alarm lab stations. Each lab will have an intelligent fire alarm control panel, horn strobes, smoke detectors, modules, and a water flow switch. The labs will be put to use not only for the apprenticeship program but also for continuing education. The new equipment is mounted to a back board that can be removed when not in use. This modular design will allow us the flexibility to add labs without the need for more lab space.

### Home Sweet Home To Buy or Not to Buy?



# Safety Corner Can You Hear Me Now?

Let's talk about communication on the jobsite. The number one reason for mistakes, and I'd be willing to say accidents on the job, is communication errors. We don't really plan on being unsafe, but we are mentally conditioned to interpret what we see and hear with what we know about the world around us. A simple example might be hearing the foreman say "Go to the panel and disconnect the circuit we are working on and remove it from the panel." Past experience tells you that you have successfully removed wires from live panels before, so the boss must have meant to do the job in the panel while it is energized... But that's not quite what the foreman said. Is it what he meant? It's an excellent opportunity to get clarification before proceeding. A couple of quick questions could save you from looking foolish, or worse, becoming seriously injured. Most companies' owners/leaders want their employees to be safe, all the time, but somewhere in the middle the message gets lost. Often times we as electricians feel like the message is "Safety is for Appearances, Productivity is our main Priority." Let's not get caught up in seeing how short we can cut the corners. Start listening to what the company is asking for, and when it isn't in line with our own safety culture, ask questions.



### Solve the Partisan Divide

In American politics we keep hearing that a divided Government is good, it allows for a compromise. Compromise is a good thing; each party taking a position then works to find a middle ground for both to exist. A fair-even proposition can't be made when one side continues to say no.

Take the Southwest LRT for example; the deal was struck at the end of the 2016 session that would fund the LRT, which the House Majority Leader, Senate Majority Leader and the Governor all mutually agreed upon. When the actual bill came out of the House and onto the Senate floor the bill was flawed, and it didn't contain all the provisions of the agreement. Thus the DFL controlled Senate made an amendment and sent it back to the House. The House Republicans did a masterful job of running out the clock and adjourning the session leaving the State's work undone. This was a result of some hard and rigid Republican Caucus members that couldn't stomach a fair and compromised deal. They wanted it their way and only their way, they are fully satisfied with no compromise. The end result is a divided Government that has failed to Govern; these negative results have fueled the anti-establishment sentiment in our country. Many have felt for quite a while that we should throw them all out, replace them all! It's easy to understand the frustration having lived it. If there is one thing that we have learned from Governor Jesse Ventura is that bringing in an outsider

candidate doesn't solve anything. It just creates more division and partisanship. The only answer to our political problem seems to be, to give Governor Dayton a DFL controlled House and Senate to solve the partisan divide. For years as a Building Trades lobbying group, we have tried repeatedly to talk with and have an open dialog with the Republican Caucus members and most have not listened to our labor concerns. When you go into the Voting Booth you have a chance at solving the partisan divide.

When voting, I consider my Grandfathers who both had good paying Union jobs in Northern Iowa before Right to Work (for less) then about how their pensions were robbed from them. Right to Work (for less) had a huge negative effect on my Mom and Dad's wages and benefits packages. Then I contemplate my children's heritage of a long line of honest hard working people, who are looking at starting from a deep hole of educational debt that could keep them indebted for a lifetime. I worry about the possibility of Minnesota becoming a Right to Work (for less) state and how it could haunt not just two generations of my family but four generations. It's time for Union Members to realize that taxes, gun control, religion or race, does not TRUMP the plight of the working class. It's time we ALL vote together to solve the political divide. Vote early. VOTE Labor Endorsed. In GOD we trust.
