

### FROM THE BUSINESS MANAGER'S PERSPECTIVE

At the time I am writing this article, we have roughly fifty days remaining until the election on November 8th. I know, if you are like me, politics may not be your favorite topic, but we must ALL participate in the

political process to have our voices heard. We have all heard this before, but this **IS** the most important election of our lifetime. We need to unite and support labor endorsed candidates that care about our economic interests and our union values. We cannot afford to be divided on the topic of economic security for our union way of life. Please review and support the candidates that your Local and International Unions have endorsed. endorsed candidates can be found on the Local 292 website (https://www.ibew292.org/political) and in this publication.

Local 292, and all organized labor, support candidates who share and/or support our union values and our union way of life. We support candidates who support us! These candidates support collective bargaining rights, prevailing wage laws, project labor agreements between owners and labor, and strong licensing laws for our industry. These candidates oppose right to work legislation, they oppose attacks on our pension plans, and they oppose legislation that will lead to the weakening of unionized work forces in our State. If we lose a labor-friendly majority at the Minnesota Legislature and lose our friend Tim Walz as Governor; Minnesota will become a right to work State. We will lose prevailing wage requirements on state funded construction projects and our electrical licenses, inspections, and regulations will be weakened. If Minnesota becomes a right to work state, the wages and benefits we are making right now, will be the most we will ever make.

We do not support candidates or political parties blindly. Our Committee on Political Education ("COPE") thoroughly investigates and screens each candidate, both locally and nationally, that we endorse. This committee then recommends these candidates for endorsement and only then do they get the endorsement of Local 292. Again, we support candidates who support us. These candidates are who we believe will help us preserve and expand our initiatives by introducing and supporting legislation that will ensure union members continue to thrive.

Currently, polls indicate that a vast majority of United States citizens view unions favorably. Now is the time to get involved in politics at all levels, including Local, State, and Federal races. It is up to us to be the change we want to see in our State and Country. We can make a difference by helping to get labor-friendly candidates elected into office. Labor needs all hands-on deck this election. Get out to the polls, get involved, and help make this an election that will change the course of labor for the better.

# **News From the JATC**

We are off to a great start for the new school year! The 2023 NEC Code book is out, stop by the JATC to receive your copy or sign up for a Code Class and learn about the new Code changes. Continuing education classes are open for enrollment, register online. More classes will be added throughout the year, so continue to check online at https://mplsjatc.org.

We are making a concerted effort this year to increase the amount of lab time the apprentices have at the JATC. The Electrical Training Alliance has been working on the Computer Mediated Learning (CML) system which allows the apprentice to learn online, reduce lecture time in the classroom, and allow more lab time. We are going to increase time in the conduit bending lab with all types of raceways, the transformer lab, applications lab, and the test instruments lab with performance testing as a final component. It is a combined effort between JATC training, and the training that everyone provides on the job to train our future apprentices into the best Journey Workers in the industry. Thank you to all that train our apprentices!

To provide for a fair and partial selection process, we are switching our selection procedures to the use of GAN Human Resources. They utilize a battery of aptitude tests consisting of numerical computation, numerical reasoning, reading comprehension, paper folding for ability to visualize 3-dimensional figures from 2-dimensional drawings, and mechanical reasoning. In addition to the tests, the applicants will complete a personal experience form indicating work history, educational experience, and other relevant application information and letters of recommendation. Based upon the test results, personal experience form, and letters of recommendation, GAN creates a ranking list for entry into the program. They currently have a 93% completion rate of who they place into apprenticeship programs. Our completion rate is approximately 70%. We will be switching to this system this fall. Thanks for all the support to the JATC and thanks to all the support to the education of our apprentices!

Some news from the State of Minnesota: Governor Walz signed the first-ever Veterans Omnibus Bill that included funding for a service bonus payable to eligible veterans who served from 9/11/01 to 8/30/21. Amounts vary between \$600, \$1,200, and \$2,000. Check the following website to see if or what amount you qualify for.

Veterans can use the Minnesota GI Bill to pay for your electrician license renewal. This is in addition to and separate from the Federal GI Bill. All honorably discharged veterans are eligible so check out this benefit at the following website.

The government passed the PACT Act Law. The PACT Act is a new law that expands VA healthcare and benefits for veterans exposed to burn pits and other toxic substances. At the 40th IBEW International Convention, an amendment to Article IX of the IBEW Constitution was passed. Effective January 1, 2023, there will be an International Monthly Dues increase of two dollars (\$2.00) for the per capita that is paid to the General Fund that applies to <u>all</u> members and an increase of two dollars (\$2.00) for the IBEW Pension Benefit Fund (PBF) contribution that applies to "A" members only, therefore the rate for all members shall increase.

If your International Dues are payroll deducted, please check with your Employer that your dues deduction is adequate.

This **<u>DOES NOT</u>** affect the working dues. The working dues will remain the same at this time.

### Did you know?

- 1. Any "A" Member who is two (2) months in arrears and requests an application for the IBEW PBF, the application will not be available until the member is in good standing.
- 2. No IBEW PBF death benefit shall be payable upon death of a non-retired "A" member if such member was more than two (2) months in arrears in dues payments, unless it can be demonstrated that the arrearage was not the fault of the member, in which case the death benefit shall be reduced by the amount of the arrearage.
- 3. Suspended members (those who are in arrears to their local union for 3 to 6 months) forfeit all rights and previous standing in the IBEW. If reinstated, their standing and eligibility to run for local union office dates from the time of reinstatement.
- 4. You are still required to pay your quarterly dues until you are retired from the IBEW Pension Benefit Fund (PBF).
- 5. Whenever the balance in the Local 292 Death Benefit Fund drops below \$5,000.00, all participating members shall be assessed \$15.00 except retired members who are members of the IBEW Pension Benefit Fund. This is NOT payroll deducted and it is the member's responsibility.
